Student Artist Division: High School and College/University Students living within a fifty-mile radius of Quincy, Ill

Artist Division: Individuals, age 18 and over, living within a fifty-mile radius of Quincy, Ill

All works meeting the following criteria will be exhibited.

Criteria Artists may enter up to 3 works in either division, in any medium, and at no cost. Artwork must reflect the theme, 'Fall Colors of Street Rodding', and depict a pre-1949 Street Rod. Please see Street Rod resources listed below. All artwork must be original. No copies of copyrighted imagery are allowed. All two-dimensional artwork should be matted and/or framed. No damaged mats. Three-dimensional and two-dimensional artwork cannot be over 3 feet in any one direction. Artwork requiring a digital presentation must come with its own viewing device. Works will be displayed on easels, tables, and pedestals.

Awards All awards will be presented at the discretion of the judge. Criteria for awards include originality in expressing the theme and quality of artwork. Each division will be awarded cash, Art Center gift certificates, and Quincy Mall gift certificates. Cash awards will be in the amounts of \$250 Best of Show, \$150 Second Place, and \$100 Honorable Mention. Award winners will be publicized after the exhibit and used in future marketing of the Early Tin Dusters, Quincy Art Center, and Quincy Mall.
